



"General Insurance Intermediary" (previously known as "non-regulated" users) have access to non-regulated products only (such as level term, mortgage protection, family income benefit and income protection). IFAs will also have access to additional life products, such as annuities.

Payment Method

Payment is £11 monthly by Direct Debit, and gives you access to all applicable products. You will be emailed a Direct Debit mandate to complete and return, together with an invoice. To pay by any other method, please click "other method" and you will receive an invoice for £132 per year. NOTE: Your fee includes 5,000 quotes per month per registration. 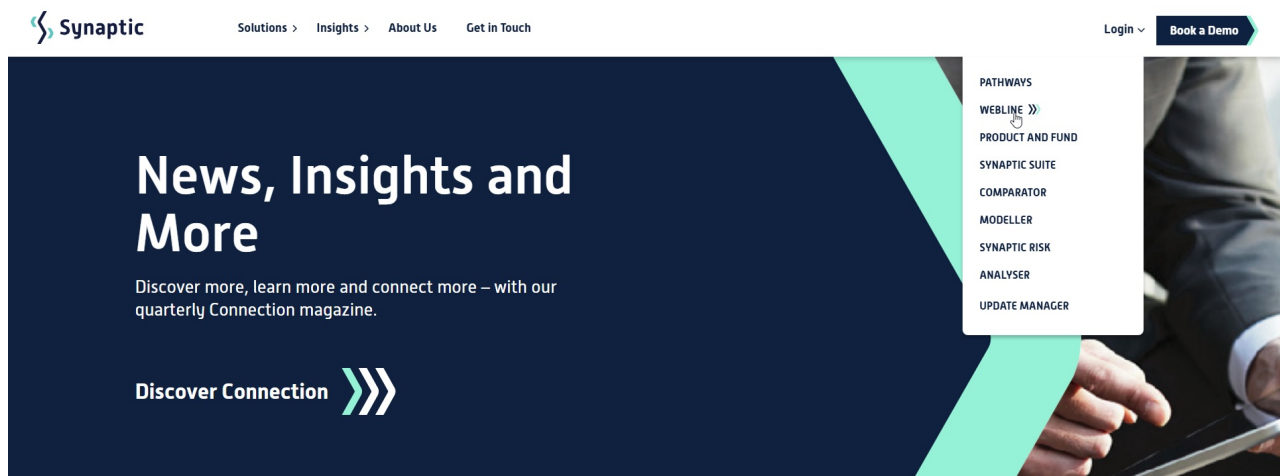
